DALLAS, Nov. 2, 2018 – *U.S. News & World Report* and *Best Lawyers* have released the 2019 Best Law Firms rankings. These rankings assess a firm's combination of quality of law practiced and breadth of legal expertise. Winstead PC was acknowledged in 34 areas of practice, including 20 in the national tier rankings.

Ranked firms, presented in tiers, are listed on a national and/or metropolitan scale.
